I have just read the "article" in the Saturday Evening Post on "Scientology".

THE MINUS SIDE

Here we find all the old saws, the standard propaganda line of the world of Authority.

This "article" is a rather clumsy effort to discredit the leader of a movement by direct personal attack.

This is in actual fact assassination of character. They cannot simply shoot one - for that makes a martyr. So they assassinate one's character.

By misquotes and inferences, statements out of context and avoiding all actual values, they seek to kill confidence and therefore the movement.

But the charges are very old hat indeed. We have been seeing the same things for 14 years. Same lies. "They're only interested in money." "It's all ridiculous." "Authority disapproves." "Not recognized." "No degrees."

There are only a few things that support the world of Authority. The propaganda runs: "Medicine is selfless." "It is authority." "It is recognized." "They have degrees."

That authority drains some huge percent of national income, that they often kill, that the public is not sold on doctors and that degrees do not make results are all true but never mentioned by such conservative magazines.

So such an article is based on a false premise - that somebody has it all comfortably in hand and that all newcomers are false interlopers.

Such articles are vital to maintaining the monopoly or Authority.

By seeking to discredit the person at the head of the movement and not the work itself, such an article avoids the delicate fact that the work might be valuable.

So the minus side of the article is mainly that I have been attacked personally and Scientology has been ridiculed.

That Phelan and the Post opened themselves to a big libel suit in uttering such lies shows how far they are willing to go - which is pretty far. The medical-government monopoly is worth over 5 billion dollars per annum internationally. It would do anything to protect itself, even earn a half a million libel suit.

The article was published when it was and said what it said to help the U.S. Government in its suit on E-Meters. It was held for some time to co-ordinate with the government attack.

In England and elsewhere newspapers are restrained from influencing trials but in the U.S. the government encourages the practice.

THE PLUS SIDE

The article could not avoid certain revelations:

- (1) That Scientology is huge.
- (2) That it is successful.
- (3) That it is efficient.
- (4) That it is growing.

These facts were made very plain and a great many people will see them.

The article got the word SCIENTOLOGY spelled right and spread around.

The article gave points of great mental interest to people and will start some thinking.

It did not demonstrate that Scientology didn't work.

It got the data about I.Q. rise solidly presented.

But above all it was too savage. The datum about its growth does not compare with the datum of how bad it is. This brings about disbelief.

People are prone to believe that things which are fought must be suffering an injustice. The underdog complex will make many people turn against the Post's opinion. The Post notoriously stands for Authority. The article, then, will bring a question into many people's minds and will swing many others over to our side.

In this article, it is of interest to note that the Scientologist is no longer portrayed as a peaceful person. He is characterized as threatening and violent.

Peaceful movements get very badly mauled as history shows. So it is not bad to be considered dicey to fool with.

But this invention of the violent Scientologist is a new lie we will see more of, no doubt.

SUMMARY

If you're not talked about at all, you're dead.

The article shows we are not only alive but that we are growing.


It shows there is money. Therefore it shows success.

It is mainly an attack on me personally, and Scientologists are used to defending that.

It advertises that there is a controversial, successful subject in the world called Scientology that is growing despite all attacks.

To me it only demonstrates the difficulties of bringing philosophy to a highly materialistic Western world. They are not used to adepts, knowledge and a better life.

And it only indicates to me that we'll have to hold them down and get some shoes on them. We can. They've run wild too long already.



CLASSIFICATION

HCO Policy Letter of February 23, 1964

The final shape of Classification Policy, now that opinions are in, some of them belated, is as follows:

Auditors will be classified from I to VI as in the original issue.

In response to numerous field requests, the original issue is changed as follows:

Preclears will be separately classified, Levels I to VI. Classification will be on the basis of processes flattened. Each level will have certain basic processes to be accomplished. Preclear Classification will not be by certificate but by a specific log book issued to the preclear and signed by his auditor as each process is flattened and a level completed. Technology now permits this to be effective and it will prevent case failures.

The same log book will be issued to auditors and they too must attain their own preclear level to compare with certificate. Certificates and current classes to be valid until 1 July 1965.

Classification of auditors and preclears effective date is extended to 15 April, 1965. The processing log books will be issued before that date.

The log book also applies to Co-Audits.

Founding Scientist Certificate issues are going forward, allowing up to Class IV for trained auditors and Class IV for preclears. The actual certificate must be possessed by the individual to be in effect. Fact of having been a Scientist or Dianeticist for years gives no dispensation unless the Founding Scientist Certificate is in hand.

HGCs and Saint Hill trained auditors may issue special dispensation to HGC preclears and their own personal preclears to temporarily raise their preclear class during certain phases of processing.

Effective 1 June 1968 field centres duly established with Saint Hill graduates may train to levels as high as IV and are permitted effective 15 April 1964 to train to HAS Class I and HQS Class II. On 1 June 1968 Central Orgs will be permitted to train to Classes V & VI, which until that date will only be taught at Saint Hill.

Otherwise the basic policy letter is unchanged. A summary issue will be prepared and released.

This policy has been formulated with the consultation and majority agreement of organizations and field auditors all over the world and is final.

The effective date is now 15 April 1965.



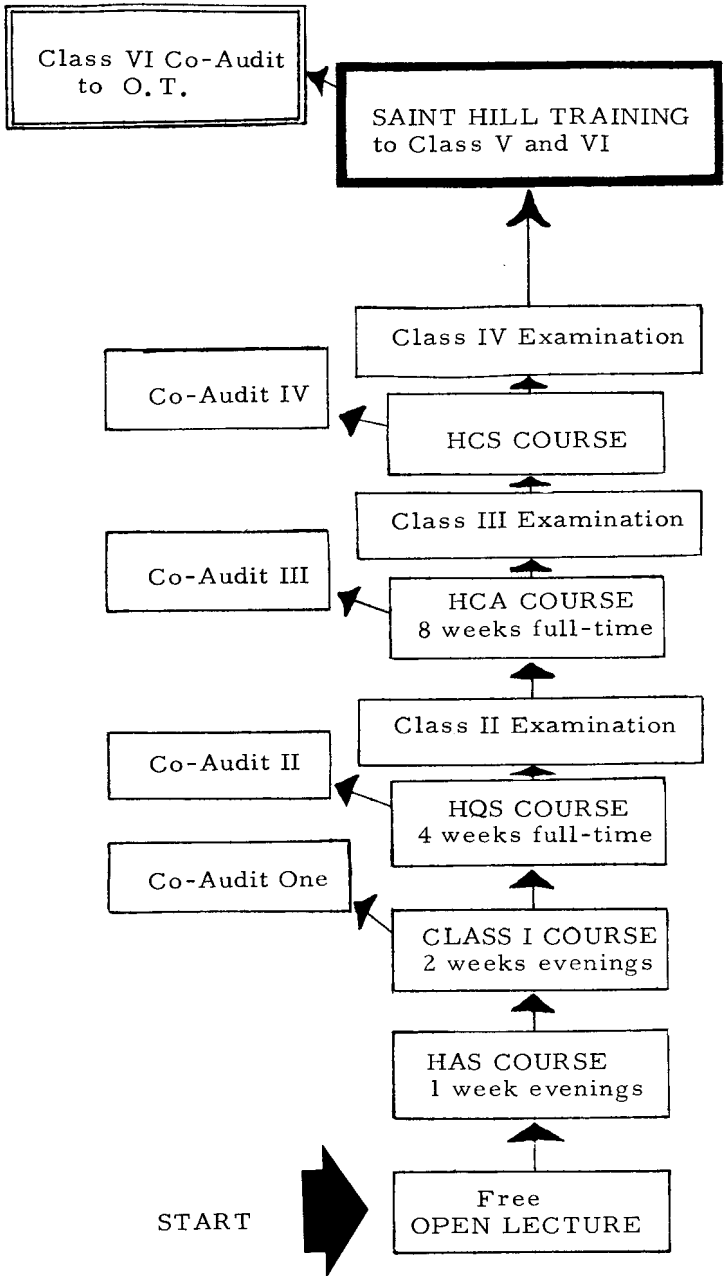
FIELD AUDITOR CONSULTANT POST CREATED

This is the post to write to for HAS and HQS certificates for your students and for getting them in to take their examinations for classification.

Ron's Journal No. 9

Well, I had a wonderful, wonderful birthday. Cards and cables and presents. And above all good wishes.

When you've been working until bone weary and fighting the good fight and you suddenly find how many care, your heart warms right down to the center and you look up and see the brightness of the day.

Bring on your lions. I've got friends. And that's what counts.

So thank you, thank you for pulling me up and giving me a new send-off for my next year.

Consequent to my last personal journal, "Charles" our butler gave me a small tree and a tiny table and chair and coke chest (all toy size). "Charles" is quite a personality from a lifetime of being a purser on big liners and inevitably was referred to by Phelan, the Saturday Evening Post AMA employee, who said in a comment, "He has an English Butler" - which you will agree is quite rare and novel in England.

Jan Halpern sent me half a carload of pocket books.

So I've got the tree.

And now all I need is the TIME.

The students now on course gave me a pair of Chinese swords for my office and the staff gave me a beautiful crystal goblet with my zodiac on it. Amongst many such appreciated presents was a Polaroid 100 Picture a Minute Camera which Reg Sharpe gave me with lots of extras. Just the night before I had found and run out a GPM about making pictures. So now I can. GPM gone and camera in hand. We had a wonderful laugh over the coincidence.

Class VI materials are really complete now. We have about 30 on the Class VI course here now, all of them having finished their Class V. Makes about 50% of the students present actually on Class VI. It's really not as long a course as others we've had but very exacting. An auditor has to do well on the earlier auditing course just to begin it. And is this first SHSBC Class enthused! They're bright eyed and bushy tailed.

I gave them their first clay table demonstrations of GPMs last Thursday and Reg and his crew got two half hour 16mm films of it. It came out very fine. And unless they lose the films on the nationalized railway we've got something good.

A bit of a strain doing 2 one half hour films in an hour and a half - but schedule requires that pace if I'm ever to get it all done for all classes.

New magazine about to come out from here "The Auditor: the Saint Hill Journal for Auditors". Replaces the projected Saint Hill News. We've formed "The Auditors Division of HCO WW" for all the auditors in the world.

Re-organization goes well. We couldn't get non-profit for HASI Ltd., so we're forming up orgs individually in areas all under HCO (WW) Ltd. direction. And I'm seeking to convert HASI Ltd. to the world wide auditor's organization. People become members of their local orgs and auditors members of the big org. I'll give you more about it soon. It works better this way.

Classification changes invited the say of all auditors in the world. And I listened carefully and found they wanted auditors and preclears separately classified. So that's the way it will be done.

Preclears will have log books which contain a good workable programme of auditing to be checked off. Auditors will be classified by training. And will be classified as preclears also.

There are now 3 routes - 1, as an auditor. 2, As a co-auditor or member of a co-audit and 3, As a preclear.

Auditors do what I ask them to - but on Classification I wanted them to have what they needed and when they wanted three routes open as above, they got it.

So I hope everyone's happy now.

The war in Australia is going well. We're winning and getting good press! My hat's off to the Melbourne auditors. What a job they're doing!

The Saint Hill staff completed their course on Class VI and all passed after months of grind and an exam that gave them the shakes. And they're now cheerfully finding GPMs on one another and completing their goals plots.

They're the first trained Class VI auditors in the world and they're headed for the Super clear state of O.T. with rave notices from all of them.

Mary Sue also got her classification on that course.

She's doing a superlative job of auditing me. Tonight we reached the top of GPM No. 12, which means 5½ actual GPMs run from the start (truncated series began at No. 5). And it's green light all the way.

We just re-ran one tonight earlier run by other commands for research and not one real Item on it above the goal had been found before!

Former auditing on GPMs on me was all research, like fighting tigers without tools, and it took its toll. Must have been

several thousands of research auditing hours on it all - or more, I haven't counted it up. Just to find out how. Well we sure have how now.

We ran two GPMs tonight on me in two and a half hours, ran them clean as a whistle. What a relief to know it's all accurate now.

One has to have a full plot of Actual goals first. That's the trick. Mine was completed some weeks ago.

So it's been a great birthday and its a great year coming up.

And I want to thank all of you who helped - and who made it worthwhile.

INDIVIDUAL INTENSIVE AUDITING

THE SPECIAL POSITION OF THE HUBBARD GUIDANCE CENTER IN THE NEW PLAN FOR SCIENTOLOGY -

As you will see while reading this issue of ABILITY, the new plan is going to give a lot of people perhaps their first chance to use Scientology to help them to make the gains in life which they want, and to shape their lives as they wish.

This is as it should be; for the purpose of the plan is to give more service, to broaden the courses available, to eliminate any barriers of time, of money or of knowledge which could prevent anyone from making good use of Scientology.

It is no part of the purpose of the plan to dispense with or alter existing services. Recent emphasis placed on the Academy and on Co-Auditing does not mean that the Hubbard Guidance Center and individual intensive auditing are not just as available, and just as important, as they always were.

The HGC is still open to everyone who wants auditing on an individual basis, and will always be here for you to rely on for this service.

Far from detracting from the importance of the HGC, the new plan enhances it. It means that the skills and data which are producing such excellent and speedy results in the HGC have been found to be so effective, and are so well understood, that some of them can now be taught and used in co-auditing on the lower levels to produce very good results. The HGC auditor has all these skills to help his preclear, and uses them with all the knowledge and understanding he has learned during his long training and practice in Scientology.

There is nothing new in the new plan which need upset your plans for auditing in the HGC. If you want training, but have no time to co-audit afterwards, you are free to choose auditing in the HGC instead. If you do not wish, or cannot manage to have training, you are still free to have auditing in the HGC.

Training is not a prerequisite for auditing, and there is no qualification required of anyone coming in to the HGC. Or rather, there is one: that you should want to be audited. That is all we ask. For Scientology and the HGC are here to help you do the things you want to do.

Are You Using Your Full Potential?

Do you realize that mankind is only using one tenth of his potential ability?

This fact in itself is hardly worth noting, until one looks closer at exactly what this means in terms of what results from it.

For instance, the average I. Q. is from 90 to 110; anything below that is considered "sub-normal" or sub-average, anything above that is considered "good" or if it is 20 points above that "Genius" (these people are a bit "eccentric"). What exactly are the implications of this?

If our average is 110 and we are only using one tenth of our potential ability, what would the average be if we were using all 100 per cent??? Our "average" I. Q. would be 1100! Right?

Where does that put us with our average I. Q. of 110? If we think now, from the "lofty realms" of our very "high" I. Q. of 110 that those with I. Q. s of 70 are idiots, where does that put us with people who have I. Q. s of 1100?

To illustrate a bit more, let us examine what we harvest from our lofty I. Q. position of 110, which isn't hard to do.

What are we currently concerned with?

1. Poverty
2. War
3. The production of more powerful weapons, to reap even more war and destruction.
4. Sex
5. Sickness
6. Government
7. Slander and gossip
8. Theft
9. Murder
10. Social position
11. Ways out of these problems (by a very small minority).

Now let's look at what we are doing about it.

Psychologists and psychiatrists, and the study of, concentrate solely on the "sub-average" (i. e. the sub-average of the average 110 I. Q.). The methods they use? Another beautiful example of an average society: shock treatment, lobotomies, drugs, hypnosis, etc. And even if they succeed after all this, which is seldom, what to they have? One more joining the ranks of the vast majority which itself is very SUB-normal.

The medical profession concentrates upon curing the BODY manifestations of a sub-normal mankind, which are bad and will continue to be bad as long as they sit at 110 on the scale of ability.

Government is a joke, because what do we have? Average People, elected by the majority (which are average) attempting to govern the average with laws dreamed up and passed by the average! Funny, isn't it? Or is it the opposite, very, very sad? ?

The Churches (currently being thrown out of country after country by the communists) come the closest by attempting to improve man's potential spiritual ability, but are sadly held back by a very real barrier of no workable way to do it. It is well and good for a minister to tell his parishioners to be good, to not kill, steal, commit adultery, lie, etc, but if the person is lacking in the ability to carry these things out, and cannot comprehend a higher realm of understanding, how is he to do it? Sadly enough, he and the minister only get losses, and are then accused of hypocrisy by others who are having the same problem.

Educators are attempting to bring up students' ability by pouring into average students the better works of "average" (or slightly above) creators. What can we hope for at best? The students and educators cannot do better than what they are currently able to do. They can read from now to kingdom come and will only become aware of other average (or a bit better) realities and then stop.

I do not have to go into the means that these various institutions and the people in them use to go about their tasks, for it should be obvious to all now that tools used by average people can only be average and cannot succeed in taking themselves or the people they are attempting to help above that average! Unless, of course, the person they are dealing with already is using more of his ability than the average!

What happens to this extraordinary person? Let's look at it for a moment and see just what he is to expect if he is unlucky enough to land in a society far below his ability level. Just to make it real, let's take it from what has happened to others like him who have come here before and cared enough to bother with this insane society. Dr. Einstein, ostracised; Ghandi, murdered; Kennedy, murdered; Harvey, an eminent physician of the day, 'would rather be wrong with Galen than right with Harvey'; Leonardo da Vinci, ridiculed except that he successfully hid his findings from the average; Alexander Graham Bell, ridiculed; and a current one, Dr. L. Ron Hubbard, ridiculed, slandered (his only sin being that he has created a science to help mankind out of this muddle!).

Well, we did it, all of us, and we ARE doing it now. What are we going to do about it?

There is a current group on earth today who are above average and care enough to submit themselves to persecution, slander and ridicule, to help mankind. They are the Scientologists. They have at their disposal a science of spirit, created by an individual who has at his disposal several times as much ability as the "average" (his I.Q. cannot be registered by any test created so far, but then how could it, since no one else is aware of the realm he's in to set up a test for it!) This science is devoted solely to increasing the ability of the current "average" and obtaining more and more of the Potential Ability available to all of us.

It is the intention of Scientologists and Dr. Hubbard to have a sane world and a sane YOU, and it is this means that is achieving it. We are getting results. Thousands of tests verify this in the form of I.Q. increases of many points, and is witnessed by the increased ability, happiness and well being of those who have taken advantage of this science.

Although we are having our persecution, as others have before us, we are surviving and indeed are increasing our membership with great speed (in the millions now). It is available for you right now. I hope for all our sakes you take advantage of it.

"INCOMPLETE STUDENTS"

Anyone who has had an HCA course of at least 8 weeks but who has not fulfilled all requirements for certification need only come in for personal attention on his or her check sheets to be whisked through to certification.

Here are the basic requirements for HCA:

- * Able to execute a neat auditing cycle.
- * Able to execute auditing cycle repetitively.
- * Become familiarized with current techniques briefly.
- * Able to handle session.
- * Able to read the meter.
- * Able to study and apply Scientology data.

The emphasis is that perfection is not a prerequisite. Any demonstration of skill already learned means an instant pass. No one gets re-trained on something he already knows.

We are getting incomplete cycles completed. Incomplete cycles blunt intention, degrade a being and weaken a person's power. Much attention is now being paid to getting cycles of training completed. If you once started to work for an HCA and did not complete this action, now is the time to get it done.

SCHEDULE OF COURSES

In order for you to get the fastest gain and to progress at the most workable gradient, the following schedule of courses has been developed. Your problems of time, money and day-time jobs have been taken into account and the way is open.

OPEN LECTURES

Free public lectures introducing Scientology. A two hour lecture given one or more times a week.

HUBBARD APPRENTICE SCIENTOLOGIST COURSE

For: Any person interested in being more able.

Purpose: To acquaint interested individuals with the basics of Scientology. To prepare for entrance into HAS Class I Course. To increase life and livingness effectiveness.

Materials Taught: Basic data of Scientology, concentrating on a few very workable and self-provable data (Cycles of Action, ARC, Tone Scale). Listen style auditing.

Cost: \$7.50.

Length: One week, 8:00 to 10:00 p. m., Monday through Friday.

Benefits: HAS certificate and right to audit on Level I.

Conducted by Personal Efficiency Foundation and Field Auditors.

CLASS I COURSE

For: HAS certificate holders.

Purpose: To train students to audit Level I processes and to get results. To give personal case gain. To increase life and livingness effectiveness. To issue a Level I Classification upon attendance and passing examination.

Material Taught: Review of 10 hour HAS course. Study of Personal Efficiency Course material in depth. Listen style auditing drills and Assist auditing drills.

Cost: \$20.00

Length: Two weeks evenings - Monday through Friday.

Benefits: Level One Classification with right to be trained on HQS Course. The student becomes an effective Class I auditor and can audit another Class I.

HUBBARD QUALIFIED SCIENTOLOGIST COURSE

For: Class I Auditors.

Purpose: To train the student to audit Level II processes with results. To increase greatly student's data level and auditing skills for effective gains as auditors and as preclears. To raise well above the average in Life and Living. The student is trained to give Scientology Zero lectures, HAS and Class I courses.

Material Taught: Communication Course drills, Upper Indoc. drills, Repetitive processing, CCHs, Straight-wire, Tone 40 and Formal auditing, the Axioms, Overt/Withold. There is no final examination.

Cost: \$150.

Length: Four weeks, full time days. Ten weeks, evenings or weekends.

Benefits: HQS certificate with right to co-audit on Class II processes and to complete requirements for Class II. Rights to train and to charge fees for HAS and Class I courses and to supervise Class I co-audits.

Conducted by: Academies of Scientology and Saint Hill graduates in the field.

CLASS II EXAMINATION

For: HQS certificate holders.

Purpose: To be sure HQSs have fulfilled Class II requirements fully before being allowed to undertake more advanced procedures. It is expected that the student has increased reality and ability from co-auditing and giving training in the field or in an Org. It is well to have completed preclear requirements to Class II, but it is not necessary to have done so in order to take the auditor's Class II examination.

Examination content: All Scientology Class II material.

Cost: \$5.00

Length: Not longer than four hours, with a two week wait before re-examination.

Benefits: Class II is stamped on your HQS certificate, giving rights to be trained on the HCA course.

Conducted by: HCO Area Board of Review. Saint Hill Graduate in the field.

HUBBARD CERTIFIED AUDITOR COURSE

When you have finished the above step, you are ready for the first Professional Course, Hubbard Certified Auditor (Hubbard Professional Auditor in England and other countries). The HCA Course is given by the Academy of Scientology in Washington, New York and Los Angeles and Minneapolis. This is a full time day course lasting eight weeks; some Academies offer it on weekends or evenings also.
